TEACHER'S RESUME

Mr. Robert C. Moore, 3rd Degree Black Belt, began his formal Karate training in the school of Ji Do Kwan (Kong Su Do) in Chun Chon, Korea during overseas assignment with the U.S. Army in March, 1962. His teacher was Mr. Nam K. Yun, 3rd Degree Black Belt (now 5th) and his training was directly supervised by Dr. Kwai Beyong Yun, 8th Degree Black Belt and the Director and Master of the Korean (Kong Su Do) Karate Association of Su Bak (Headquarters: Kon-kuk University, Seoul, Korea). Mr. Moore was awarded the rank of 1st Degree Black Belt through the 34th Regular Examination of Ji Do Kwan at Kon-kuk University on February 12, 1963. He received promotion to the grade of 2nd Dan through the 37th Regular Examination on February 28, 1965, and 3rd Dan on March 25, 1966.

Upon his return to the United States, he was stationed in Fort Riley, Kansas, where he organized and directed the Fort Riley Karate Club until his separation from the Army in May, 1964.

He then enrolled in Sam Houston State College, Huntsville, Tex. and in September, 1964 established the Sam Houston College Karate Team as a college-sanctioned activity, which hosted the 1st Gulf Coast Invitation Karate Tournament in March, 1965, and the 1966 Texas State Karate Championships in April, 1966.

On September 22, 1964, Mr. Moore was awarded the rank of 2nd Degree Black Belt in the United States Karate Association. He was appointed to the position of Assistant Texas State Representative on February 16, 1965 and was awarded the post of Texas State Representative on January 11, 1966.

On January 1, 1966, Mr. Moore was awarded the rank of 3rd Degree Black Belt by direct appointment of Master Trias. On March 13, 1966, he was appointed to the post of U.S.K.A. National Chairman of the Intercollegiate Division.

Mr. Moore has fought in many tournaments, and has won several 1st place and Grand Champoin trophies in major tournaments, including his present title of 1967 Texas State Black Belt Champion. He has personally helped to establish eleven Karate clubs within 200 miles of Huntsville, Texas, the U.S.K.A. Texas State Headquarters.



Excerpt – Dr. Jordan – “Mr. Robert Moore was Mr. Chittim’s first USKA Texas State representative and Dr. Jordan was a graduate student at Sam Houston State University (SHSU) working on his master’s and coaching the karate team around 1968. He lived in the dojo and Mr. Irvin Morris (another black belt) and Dr. Jordan trained all the time. One day at the SHSU gym, our head graduate professor, Dr. John Burton walked by and Mr. Morris stopped him and said, ‘Dr. Burton watch Dr. Jordan kick the basketball goal net with a flying front snap kick.’ Dr. Jordan proceeded to kick the net and walked over to the two men. In his normal graduate professor demeanor, Dr. Burton said, ‘So? The guy here before you could kick the rim.’ Dr. Jordan checked into it because he could hardly believe it. Sure enough, it was true and the man was Mr. Robert Moore.”
